2009-2010 PARTICIPATION AGREEMENT

Conditions of Participation

We, the parents/guardian of (player) _____ have read the information concerning the policies and practices of Muskego Stars Volleyball Club found on the club website (www.muskegostars.com) and understand the proposed tournament and practice schedule. Having been selected to a team, we agree to let her join the Muskego Stars Club for the 2009-2010 season.

We understand the time commitment involved in practice and competition. We have reviewed the fee schedule in this document and understand that all fees must be paid in full regardless of the duration of participation. This is due to the fact that membership in this club is limited and others were denied a position by your acceptance of a position to the Muskego Stars Volleyball Club.

The player and parents/guardians attest that the member is in good physical condition and that she has no disability, impairment or ailment that prevents her from engaging in active or passive exercise that will be detrimental to health, safety, comfort or physical condition if she does participate. It is recommended that everyone consult their physician before beginning an exercise program. By signing this agreement, we give our consent for our daughter to participate, fully understanding that, as in all sports, there is a risk that our daughter may sustain injury, possibly life threatening, in the course of participation in this program and that we assume such risk, and that, in spite of this risk, we are giving our permission for her to participate.

Moreover we, on behalf of our self and our daughter, hereby agree not to sue, institute or participate in any action or proceeding against the staff of Muskego Stars, Muskego Parks and Recreation Department, Muskego/Norway School District, Badger Region and USA Volleyball.

As the parent of my daughter (player) _____, I assume full responsibility for my daughter's actions and conduct. Should my daughter engage in any behavior that causes any property damage or any harm to any person, I accept full and complete responsibility for all such conduct and will indemnify Muskego Stars, Muskego Parks and Recreation for any liability incurred by the Muskego Stars Volleyball Club with respect to such conduct. Moreover, I will agree to indemnify and hold harmless Muskego Stars and its member and employees, the Muskego Parks and Recreation Department, and Muskego/Norway School District, against any and all claims for loss, injury, or damage to persons or property arising out of or relating to activities/conduct engaged in by my daughter in any gym, hotel, restaurant, or any facility any- way related to activities of the Muskego Stars Volleyball Club.

The undersigned player and parent/guardian agree to accept membership in the Muskego Stars Volleyball Club for the 2009-2010 season. Membership entitles the athlete to participate in practices and tournaments designated by the Club. Athletes are guaranteed equal practice time, however, tournament playing time is not guaranteed, but is to be determined by the Club staff.

Membership fees:

The annual membership fee is \$600 for ages 12 thru 18 and \$570 for 11's. \$350.00 is due on or before November 22nd. The balance, \$250 (\$220 for 11's) is due on January 4th, 2010. There may be an additional expense to purchase a volleyball. Players are responsible for this ball during the season as it is to be used during practice and tournaments. Loss or damage to the ball may result in a ball being replaced at player's expense. That decision will be made by the coach and/or club director. This ball is the property of the players and is theirs at the end of the season. Club apparel is also available for purchase with participation being optional.

Please contact or coach or the Club Director if there are difficulties with the payment schedule. Checks should be made payable to Muskego Stars. Be sure to indicate your daughter's name and team on your payments. All payments will be made at the parents/players meeting on November 22nd. The January 4th checks will be posted dated and collected at the parents/players meeting.
